Apply 6 lbs per 1000 sq ft or 260 lbs per acre through the growing season.
- **TO CORRECT HIGH SODIUM OR APPLICATIONS TO HIGH CEC OR HEAVY CLAY SOILS:**
Coverage 4000 sq ft.
Apply 12.5 lbs per 1000 sq ft or 550 lbs per acre. To assure complete and even coverage, apply at half rates in two directions.
